Any Bethel College student or organization planning on attending a conference or travel funded by the Student Government Association (SGA) or Student Organization funding, must agree to the following rules and sign this document indicating agreement. This document supplements the all Bethel College Student Policies and Community Standards.

- A. I accept the authority of the Bethel College faculty and/or staff accompanying me to this conference and agree to follow their directions at all times.
- B. I will not rent a vehicle or travel in any private vehicle without written approval of my advisor or his/her designee.
- C. I agree to stay within the general vicinity of the conference and not travel beyond this area without written approval of my advisor or his/her designee at which time I will provide information as to where I am going, with whom, and at what time I will return.
- D. I agree to sleep/stay in my own room as assigned by my advisor and not to change rooms without approval of my advisor or his/her designee.
- E. I agree not to allow overnight guests in my room.
- F. I agree not to consume any alcohol during the conference. I understand that I am prohibited from using illegal substances and/or alcohol while participating in a school-sponsored event. Timelines begin from the designated departure time and established location, to the actual return arrival time and location and every time in between.
- G. I agree to attend all conference meetings and workshops as assigned or scheduled.
- H. I agree to be on time to all conference meetings, workshops, and meals and to stay the entire time unless I receive permission from the advisor or his/her designee to leave early.
- I. I agree to abide by the dress code as established by the conference and my advisor or his/her designee.
- J. I accept that any violations of this agreement may result in me being sent home early from the conference and I agree to accept all expenses that may result from this action.

Assumption of Risk Release and Waiver of Liability

I am participating in activities sponsored or facilitated by the Bethel College Office of Student Life or sponsored by an officially recognized Bethel College student organization (**hereinafter collectively referred to as "Activities", and individually as an "Activity"**). I hereby assume the risk of participation in these Activities, where occurrences may create hazards that could place me in perilous situations. The specific risks vary from one Activity to another, and the risks can range from (i) minor injuries such as bruises and strains, to (ii) major injuries such as loss of sight, neck, or back injuries, heart attacks and concussions, to (iii) catastrophic injuries including paralysis and death. I am physically able to participate in the Activities, and know of no disability or prior injury which would prevent my participation in the Activities or potentially lead to my injury or the injury of another person.

Upon agreeing to and signing this **Assumption of Risk, Release and Waiver of Liability**, I agree to hold harmless Bethel College, its affiliates, professors, students, independent contractors, offices, trustees, employees, insurers and agents and others acting on its behalf (**the "Released Parties"**) from and against all claims, actions, suits, procedures, costs, expenses, damages, losses, liabilities (whether known or unknown), demands and responsibility. These include, but are not limited to, medical expenses, attorney fees, and court award arising out of or resulting in bodily injury, sickness, disease, death or injury as a result of the Activities.

I agree to abide by local, state, and federal law while participating in Activities. I further understand that I am not to use illegal substances or drink alcohol while participating in these Activities. I am to exercise reasonable care and diligence during each Activity.

I have read the previous paragraphs and I fully understand that I am releasing the Released Parties. I fully understand the risk and scope of the activities and hereby assume all risks, known or unknown, for participation in the Activities.
